Search Results

The Office records have been searched and no similar registered or pending mark has been found that would bar registration under Trademark Act Section 2(d), 15 U.S.C. §1052(d). TMEP §704.02.

FAILURE TO FUNCTION AS A MARK

-

Registration is refused because the proposed mark consists of nondistinctive trade dress that would not be perceived as a service mark. Trademark Act Sections 1, 2, 3 and 45, 15 U.S.C. §§1051-1053 and 1127; *Two Pesos, Inc. v. Taco Cabana*, 505 U.S. 763, 23 USPQ2d 1081 (1992); *In re File*, 48 USPQ2d 1363 (TTAB 1998); *In re Hudson News Co.*, 39 USPQ2d 1915 (TTAB 1996); TMEP §1202.02(b)(ii).

Trade dress used in connection with services generally refers to the visual appearance or image of the place in which a service is provided, such as a store or restaurant interior décor or external façade. *See, e.g., Fuddruckers, Inc., v. Doc's B.R. Others Inc.*, 826 F.2d 837, 841, 4 USPQ2d 1026, 1029 (9th Cir. 1987) ("a restaurant's décor ... may acquire the source-distinguishing aspects of protectable trade dress . . .").

In the present case, the proposed mark is not inherently distinctive because it consists of a single color on the machine used in rendering the services.

In response to this refusal, applicant may submit evidence showing that the applied-for mark has acquired distinctiveness under 15 U.S.C. §1052(f) by submitting examples of advertising and promotional materials that specifically promote the mark *as a service mark* in the United States, dollar figures for advertising devoted to such promotion, dealer and consumer statements of recognition of the mark as a service mark and any other evidence that establishes recognition of the matter as a mark for the services. The evidence must relate to the promotion and recognition of the specific features in the applied-for mark. *Wal-Mart*, 529 U.S. at 211, 54 USPQ2d at 1068; *see generally* TMEP §§1212.06 *et seq.* (discussing evidence of acquired distinctiveness).

In determining whether the applied-for mark has acquired distinctiveness, the following factors are generally considered: (1) length and exclusivity of use by applicant of the mark in the United States; (2) the type, expense and amount of advertising of the mark in the United States; and (3) applicant's efforts, such as unsolicited media coverage and consumer studies, in the United States to associate the mark with the source of the services identified in the application. *In re Steelbuilding.com*, 415 F.3d 1293, 1300, 75 U.S.P.Q.2d 1420, 1424 (Fed. Cir. 2005). A showing of acquired distinctiveness need not consider each of these factors, and no single factor is determinative. *Id.*; *see* 37 C.F.R. §2.41; TMEP §§1212 *et seq.*

To establish acquired distinctiveness, applicant may not rely on use other than use in commerce that may be regulated by the United States Congress. Use solely in a foreign country is not evidence of acquired distinctiveness in the United States. *See In re Rogers*, 53 USPQ2d 1741 (TTAB 1999); TMEP §§1010 and 1212.08.

As an alternative to submitting evidence of acquired distinctiveness, applicant may amend the application to the Supplemental Register.

CLASS 9 – GOODS INCIDENTAL TO SERVICES

Registration is refused under Sections 1, 2 and 45 of the Trademark Act for “vending machines” in International Class 9 because the vending machines are not “goods in trade”. It appears from the specimens submitted that the vending machines are merely incidental to the rendering of the services. That is, the applicant does not sell the vending machines to others but merely uses the machines as part of its DVD rental services. In *In re Shareholders Data Corporation*, 181 USPQ 722 (CCPA 1978), the Court held that printed reports were not separable goods in trade when they were merely the conduit by which the services were rendered.

If the applicant can show that the vending machines are sold to others apart from the rendering of the services, the following refusal as to the use of the color red on the vending machines is issued:

Registration is refused because the proposed color mark, consisting of color applied to the goods is merely an ornamental or decorative feature of such goods; it does not function as a trademark to identify and distinguish applicant's goods from those of others and to indicate their source. Trademark Act Sections 1, 2 and 45, 15 U.S.C. §§1051-1052 and 1127; *see Qualitex Co. v. Jacobson Prods. Co.*, 514 U.S. 159, 34 USPQ2d 1161 (1995); *In re Owens-Corning Fiberglas Corp.*, 774 F.2d 1116, 227 USPQ 417 (Fed. Cir. 1985); *In re Deere & Co.*, 7 USPQ2d 1401 (TTAB 1988); TMEP §1202.05.

DRAWING/DESCRIPTION

The applicant's drawing does not agree with the description of the mark in the application. The applicant is applying for the color red used on the vending machines. The drawing, therefore, must show the vending machines in broken lines. The matter not claimed as part of the mark, including the coin slot, the window that displays the DVDs, the locked drawer at the bottom of the machine, should all be shown in broken lines. The description of the mark must also be amended to add the statement: “the matter shown in broken lines serves to show positioning of the mark and is not a feature of the mark”. 37 CFR 2.52(b)(4).

The recitation of services is unacceptable as indefinite because the goods sold through the vending machines is not set forth. The applicant may adopt the following recitation, if accurate: Vending services in the field of [indicate goods]. TMEP §1402.11.

The recitation of services is unacceptable as indefinite because the terminology “entertainment content” is too broad. The applicant may adopt the following recitation, if accurate: Automated DVD rental services. TMEP §1402.11.

Please note that, while an application may be amended to clarify or limit the identification, additions to the identification are not permitted. 37 C.F.R. §2.71(a); TMEP §1402.06. Therefore, the applicant may not amend to include any services that are not within the scope of the services

recited in the present identification.

Pending a proper response, registration is refused because the specimen does not show the applied-for mark in use in commerce as a trademark or service mark for the identified services. 15 U.S.C. §§1051 and 1127; 37 C.F.R. §§2.34(a)(1)(iv) and 2.56.
