Therefore, the trademark examining attorney maintains and now makes FINAL the identification and multiple-class application requirements. *See 37 C.F.R. §2.63(b); TMEP §714.04.*

The wording “arranging subscriptions to retail vending machines featuring movies, documentaries, full feature audio-visual content, fictional content, dramatic content, and non-fictional content” in the identification of services in class 35 is indefinite and must be clarified because it does not identify the particular services. *See 37 C.F.R. §2.32(a)(6); TMEP §1402.01.* The wording “placement of vending machines” must also be clarified for this reason. In addition, this wording appears to identify services in

class 37 rather than in class 35. *See* 37 C.F.R. §§2.32(a)(7), 2.85; TMEP §§1401.02(a), 1401.03(b).

Applicant must also clarify the wording “providing entertainment facilities for purchasing and renting DVD movies” in the identification of services in class 41 because it is indefinite and too broad. *See* 37 C.F.R. §2.32(a)(6); TMEP §§1402.01, 1402.03. This wording is indefinite because it does not make clear what the services are. Further, this wording could identify services in more than one international class. Services of providing facilities for specialized purposes are classified according to the class of the purpose - in this case, purchasing DVDs and movies is a class 35 retail store service, while rental of DVDs and movies is a class 41 entertainment service.

Applicant may adopt the following identification, if accurate (changes in **bold**, deletions in ~~strikethrough~~):

Search of Office Records

The trademark examining attorney searched the USPTO database of registered and pending marks and found no conflicting marks that would bar registration under Trademark Act Section 2(d). 15 U.S.C. §1052(d); TMEP §704.02.

Identification of Services Requires Clarification

The wording “vending machine services” must be clarified because it is too broad and could include services in other international classes. *See* 37 C.F.R. §2.32(a)(6); TMEP §§1402.01, 1402.03. In particular, this wording could encompass “refilling of vending machines” in Class 39 or “rental of vending machines” in Class 35.

A number of services listed do not belong in Class 41, such as distributorship services, kiosk services, video-on-demand transmission services, video broadcasting, and transmission of voice, data, images, data signals, messages and information by electronic communications networks, and subscription services. Applicant must amend the application to classify the services in the proper respective classes. *See* 37 C.F.R. §§2.32(a)(7), 2.85; TMEP §§1401.02(a), 1401.03(b).

A number of entries in the identification of services are indefinite and must be clarified because the nature of the services is unclear. *See* 37 C.F.R. §2.32(a)(6); TMEP §1402.01. Applicant must amend this wording to specify the common commercial or generic name of the services. *See* TMEP §1402.01. If the services have no common commercial or generic name, applicant must describe or explain the nature of the services using clear and succinct language. *See id.* For instance:

- Applicant's vending services must specify the types of items being sold
- Applicant's "subscription services" requires further specification as to whether applicant is offering retail services
- Applicant's facilities and rental services must be further specified to indicate the entertainment-related service being provided

The following amendments are suggested, if accurate (added language in **bold**; deleted language ~~struck~~; requests for further information in ***bold and italicized***):

Class 35: **rental of vending machines;** automated retail vending machine kiosk services featuring entertainment content, **namely, retail vending stand services featuring {specify, e.g., movie DVDs};** vending machine services rendered through automated kiosks featuring entertainment content, **namely, retail vending stand services featuring {specify, e.g., movie DVDs};** automated retail vending machine kiosk services featuring DVDs, movies, and prerecorded electronic media featuring entertainment content; online retail store services featuring DVDs, movies, prerecorded electronic media featuring entertainment content; computerized online retail store services featuring pre-recorded videos; distributorship services in the field of entertainment content in the nature of DVDs, movies, digital content, and pre-recorded media featuring entertainment content; **subscription-based retail store services in the field of {specify field of goods};** **arranging subscriptions to telecommunication services for others**

Class 38: video-on-demand transmission services, video broadcasting, and transmission of voice,

data, images, data signals, messages and information by electronic communications networks;

Class 39: refilling of vending machines
